ELIGIBILITY REQUIREMENTS

1. Applicants are to meet the following criteria:

- 1.1 Any natural person who accepts the requirements described in the call for applications without exception.
- 1.2 No organisations, teams or groups are eligible in this contest.
- 1.3 By submitting their photos, the applicants in the professionals' category also make the statement that they regularly work for architects or other clients in the field of architectural photography, or publish photos in the press.

2. Eligibility conditions concerning the photos submitted for the contest are as follows:

- 2.1 The applicant can submit only his or her own original photographs. By violating this criterion the application is made non-valid. By submitting the photographs the applicants also make the statement that they are their own works of art, and by submitting them they do not violate any kind of other copyright interests. By doing so, they also make the statement that they hold their copyrights exclusively, and accept and shall comply with all the information and requirements referring to the copyrights of both the artists and the users included in the call for applications.

3. Registration

- 3.1 Applications are only eligible via registration on the website <http://photoaward.meonline.hu> where the photos are to be uploaded on the individually opened surfaces.
- 3.2 The condition for registration is paying the registration fee as one sum via PayPal.

4. The Applicants' Rights

- 4.1 Applicants have the rights to modify their data and their uploaded photos till the deadline of the call.

5. The Publishers' Rights

- 5.1 The publisher of the call for applications reserves the right to modify information included in the call. The publisher shall not publish applications before the deadline for submitting the photographs, and shall treat the list of the applicants' names with confidentiality.
- 5.2 Applications submitted after the deadline shall not be accepted as eligible for the contest.

6. Uses of Applications

- 6.1 The applicants agree that the publisher shall publish reproductions of their photographs in publications and in electronic formats free of charge, and for this purpose they authorize the publisher for a limited time to non-exclusively use their photographs with crediting the photographer's name.
- 6.2 The publisher of the contest is authorized to use the submitted photographs in promotions and publications associated with the present contest and later contests, as well as concerning the exhibition organised later on. Each occasions the publisher can use the photographs free of charge, but only with crediting the photographer's name.
- 6.3 The publisher is authorized to exhibit the photographs submitted for the contest and use them free of charge in offline and online publications, advertisements and commercials associated with the contest.
